2012-06-06 Other Reports

911-Coordinator – Cathy Lowe

At this time Cathy Lowe presented the corrected copy of the 2012-2013 Budget to the 911 Board. Homeland Security - Elvis Wilson gave a report that the FCC has mandated that all radios be narrow banded by Dec. 31, 2012. Homeland Security voted to have all counties within District 7 to be narrow banded by September 01, 2012.

User Group – Chairman, Bill Holt

Bill Holt reported that the Repeater had been purchased @ the Hillcrest site at the end of June 2012.

Bill Holt reported to the 911 Board that the User Group had sent a letter to Clyde Richert in regards to the Robertson County Rescue Squad not paying their yearly radio dues (for trunking). Bill Holt to get a letter to Billy Vogle before 7-10-12. The radio trunking fees are paid yearly by each city and rural fire department for use of the radio system.

Ron Gallagher – asked about the pictures being available in the emergency vehicles. Bill Holt mentioned that the Sheriff's Office had 2-3 vehicles with the AVL installed and are still being tested.

Cathy Lowe - 911 Coordinator presented the fact that we need to purchase a measuring wheel, to help with present and future addressing issues. The model presented to the board is a Keason Road Runner Metal Measuring Wheel for the cost of \$149.99. *Motion was made to purchase the wheel by Bill Holt. Motion was seconded by David Thompson.*

Cathy Lowe – 911-Coordinator stated to the board that she had sent some paperwork to Clyde Richert, Atty., concerning the 911 – Ordinance that the board needs to have in place, since we are having to readdress the entire county.
