The 911 board reviewing the minutes for June 19, 2012. David Thompson mentioned from the minutes about the board approving the purchase of the measuring wheel for addressing, he also asked if anyone had inquired about the pricing on a new handheld GPS device. Cathy Lowe responded in saying that she had spoken with APSU and they quoted around the price range of \$4,000.00 and \$6,000.00, the more they are the more accurate they are.

Mapping – Addressing Issues – Cathy Lowe

Cathy Lowe mentioned to the board members, that she had taken (2) example copies of addressing policies to Attorney, Clyde Richert to review so that he can put a policy together for the Robertson Co. ECD, there has never been a policy initiated. The only thing we have had to back up what we do in the addressing office is the **TN. Code 7-86-127 Street Names and Numbers. Clyde Richert** to put together a policy for the 911 board to review, after reviewed and approved it will be brought before the county commission for approval.
